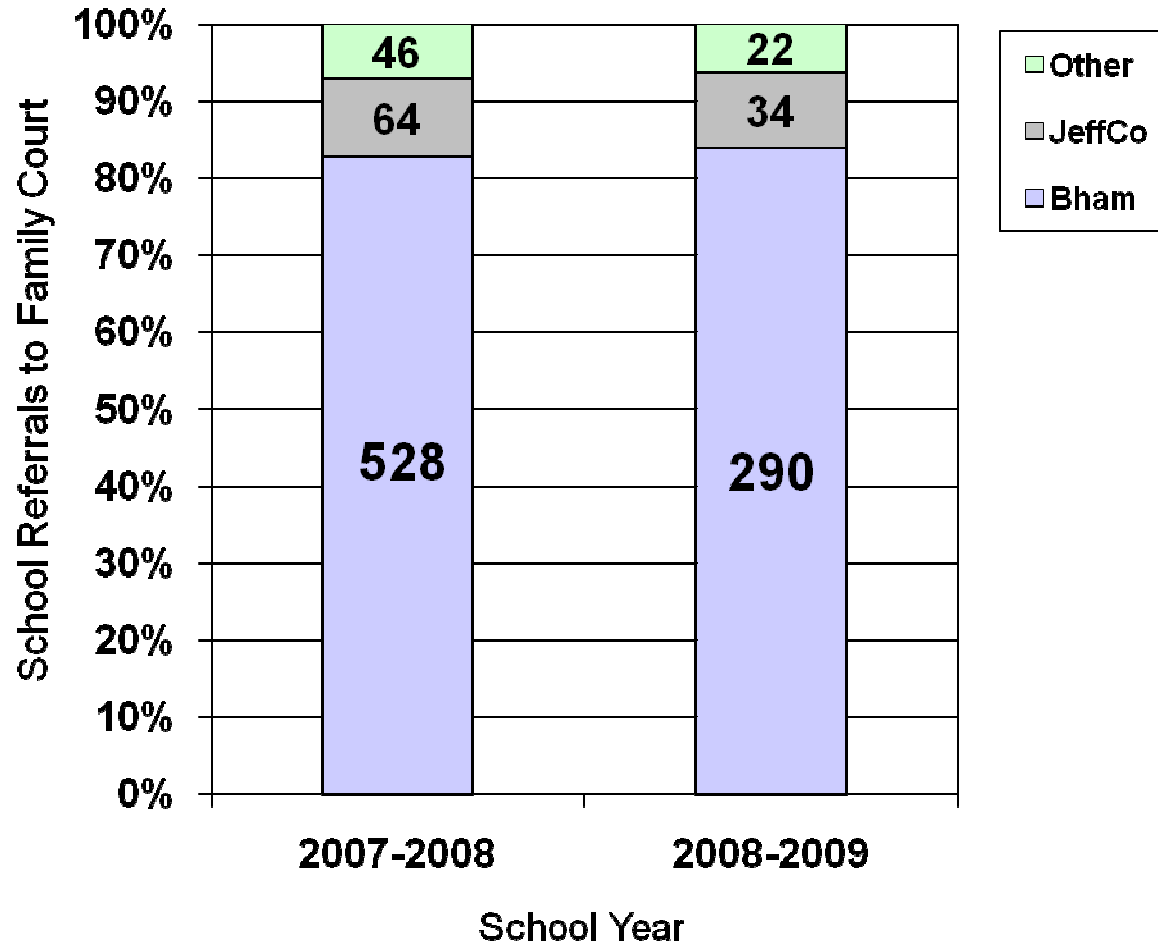

Why is it a problem?

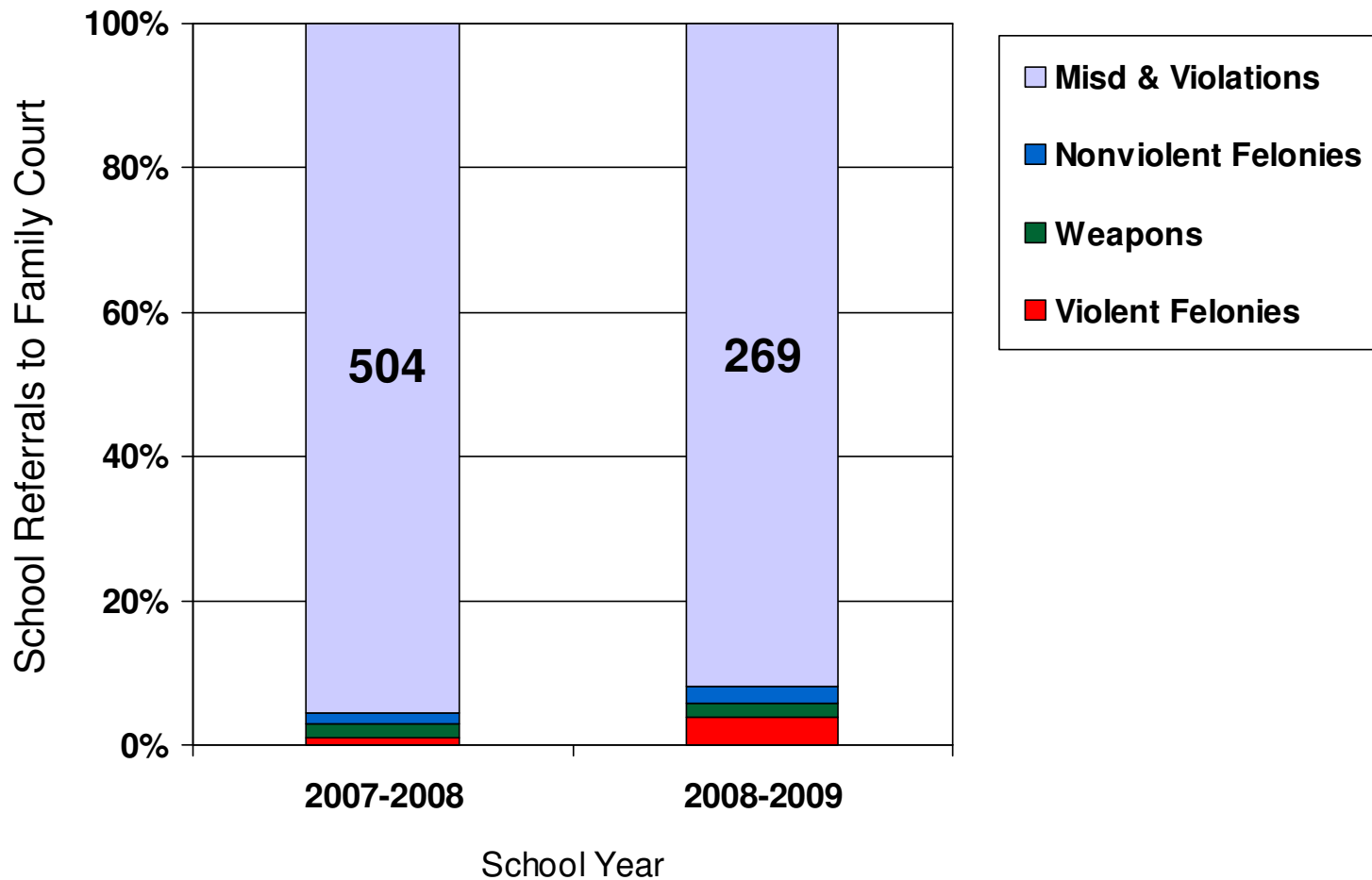
Research shows a strong link between court referrals and dropout rates

- A student arrested in high school is twice as likely to drop out
- A student who appears in court during high school is four times as likely to drop out

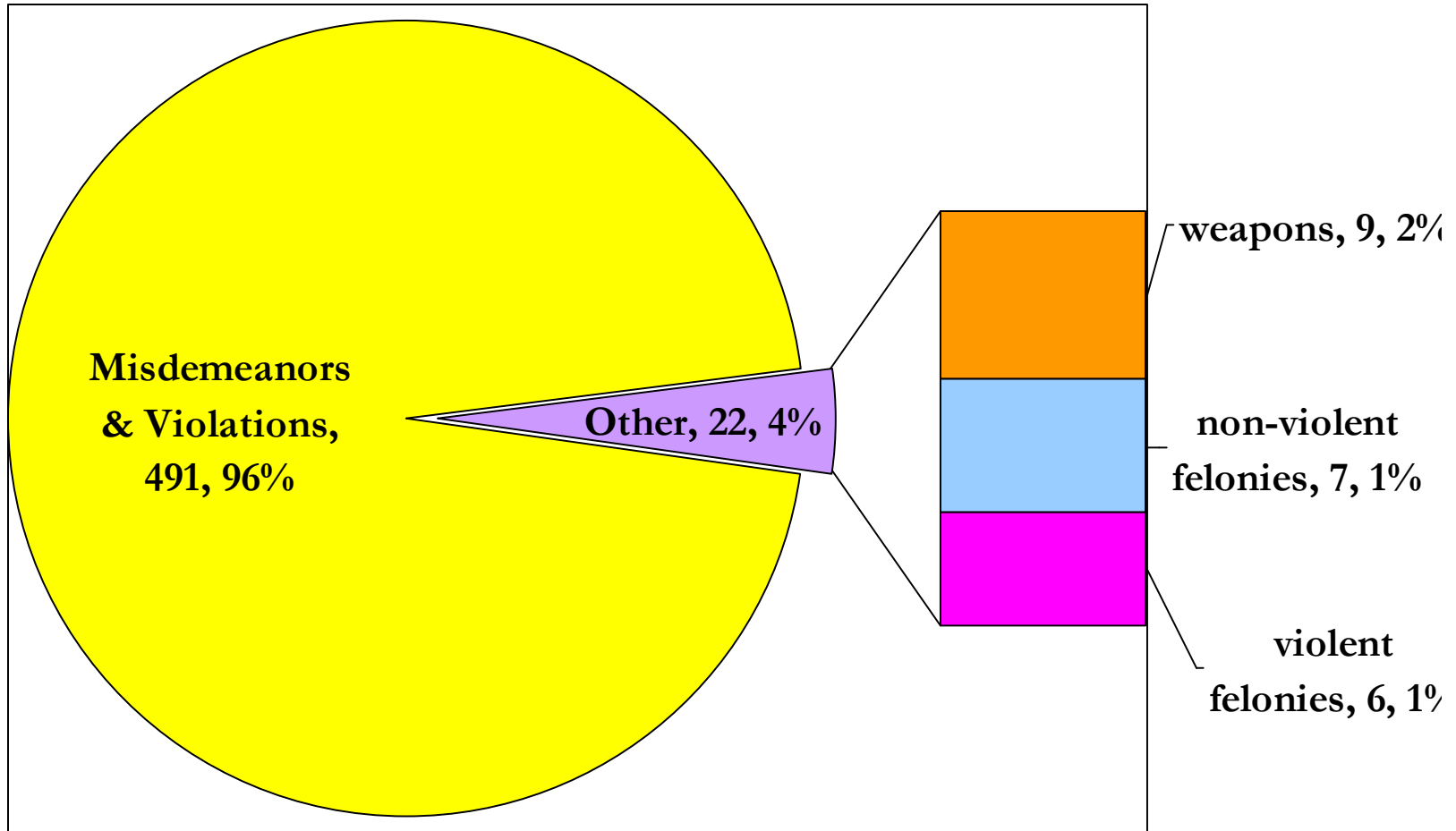

overwhelmingly minor offenses.

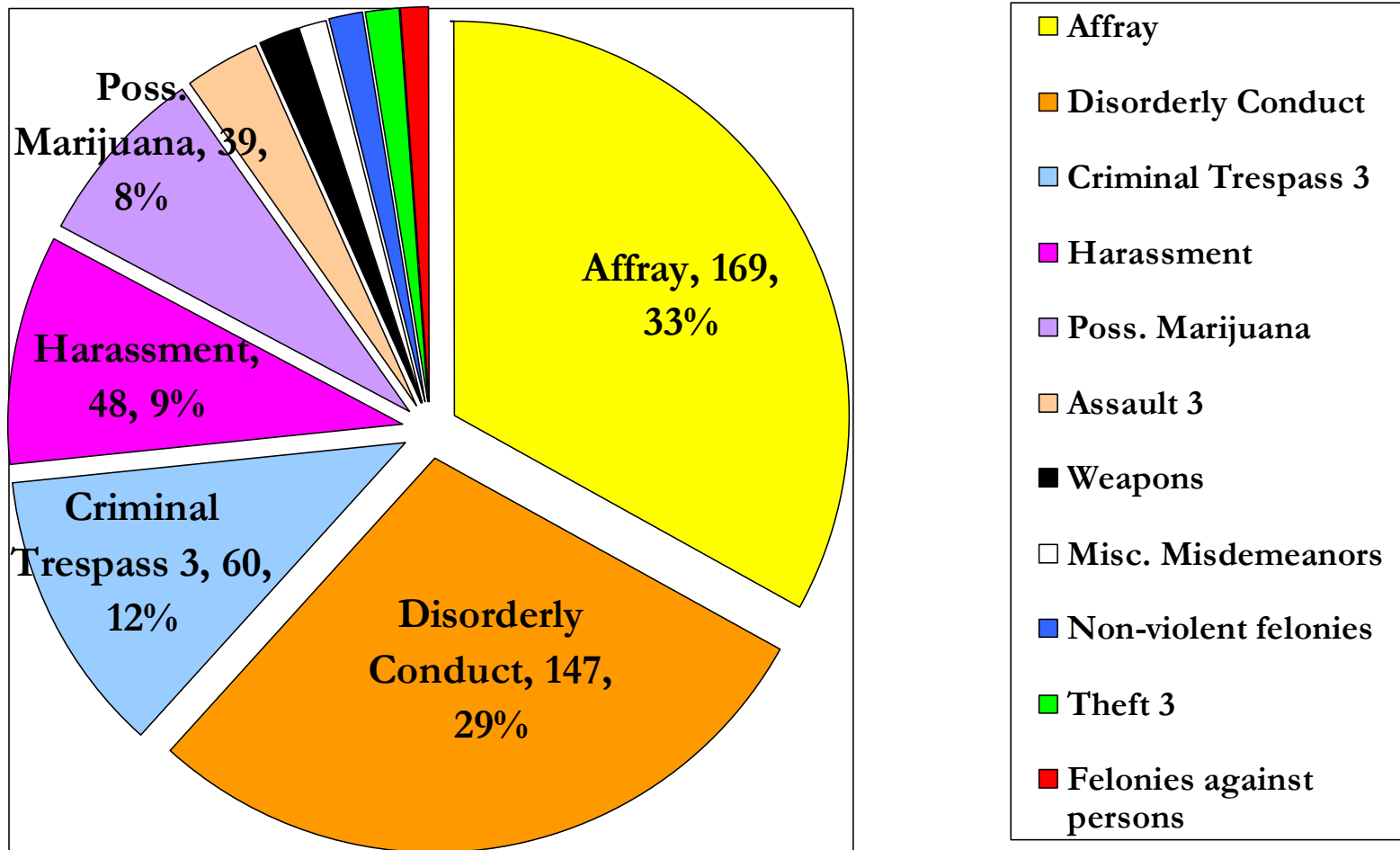
Misdemeanors and violations account for more than 90% of arrests involving Birmingham students.



Birmingham students referred to family court in 2007/08 – by offense

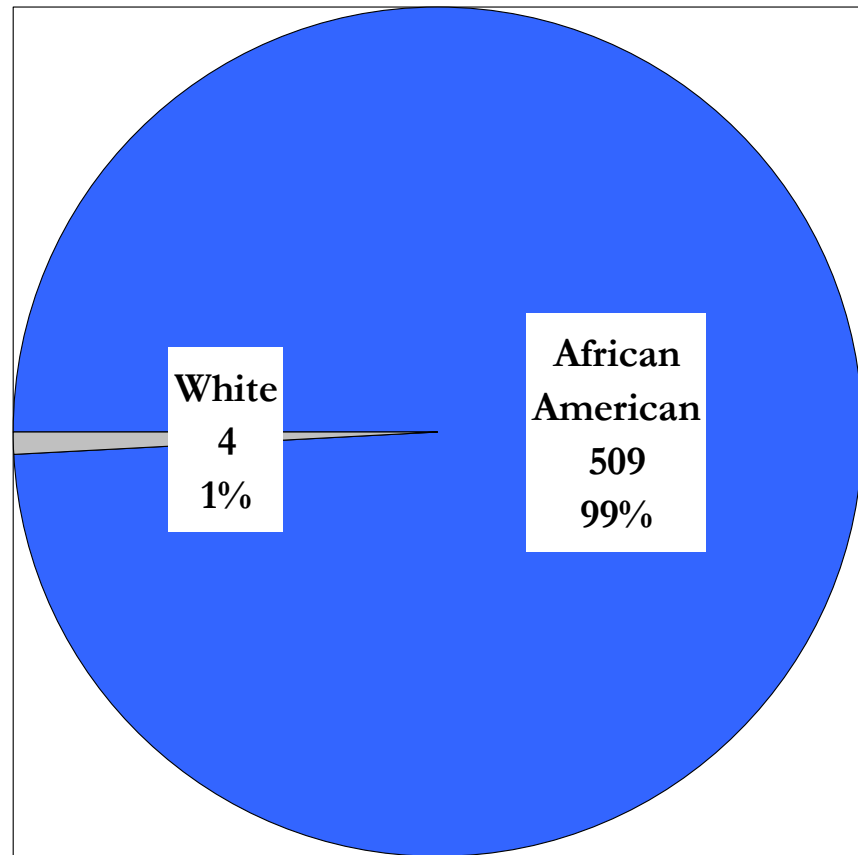


Birmingham students referred to family court in 2007/08 – by offense



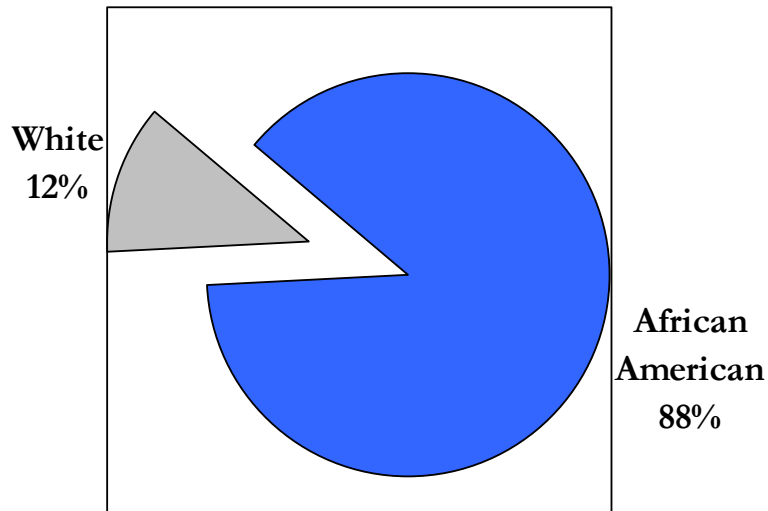
Adds to the disproportionate minority

- In the 2007/2008 school year, the Birmingham City Schools made more than 500 referrals to the Jefferson County Family Court
- 99% of the complaints were filed against African American students

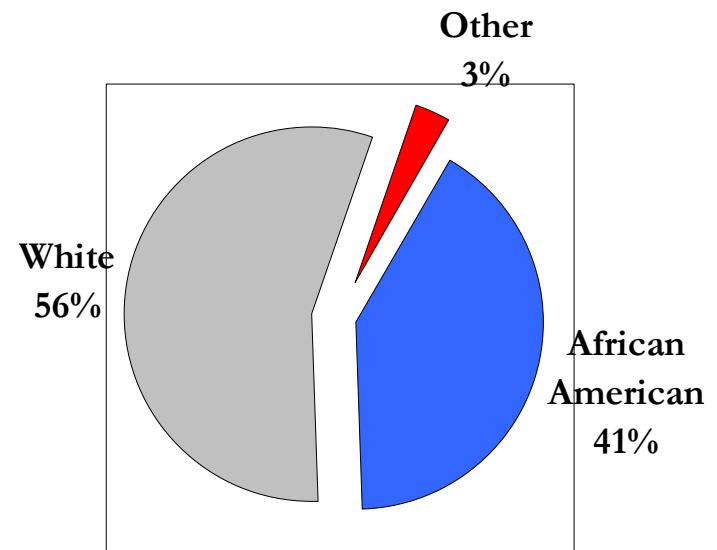


Racial Disparities in Detention

 - Jefferson County District Attorney
 - Birmingham Police Department
 - NAACP
 - Southern Poverty Law Center
 - Department of Human Resources

Decide upon a better way of discipline.

- First “offense” – warning/written citation
 - Second “offense” – Attend “School Offense Workshop
 - Referral to court

Decide which “offenses” to include.

- Affray
 - Disorderly conduct
 - Harassment
 - Assault 3
 - Criminal Trespass 3
-

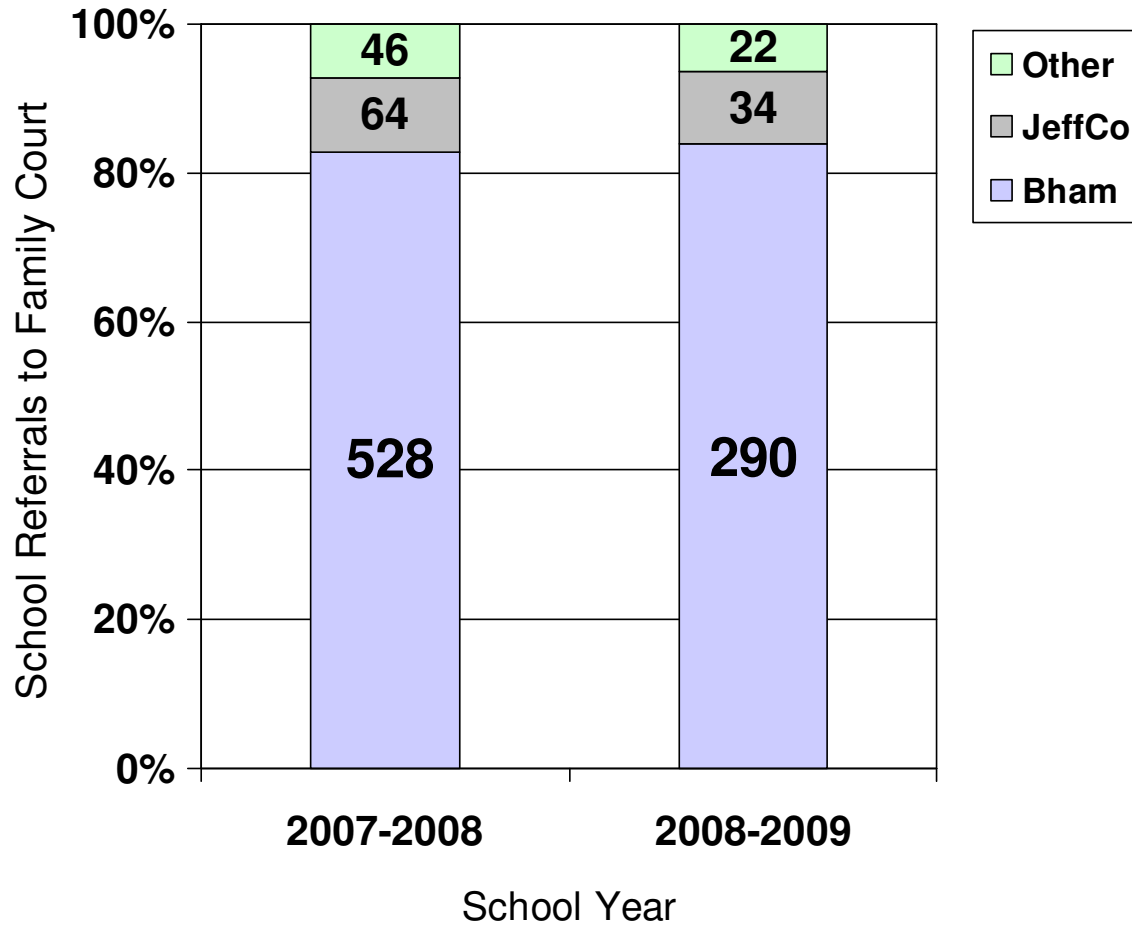
Consensus

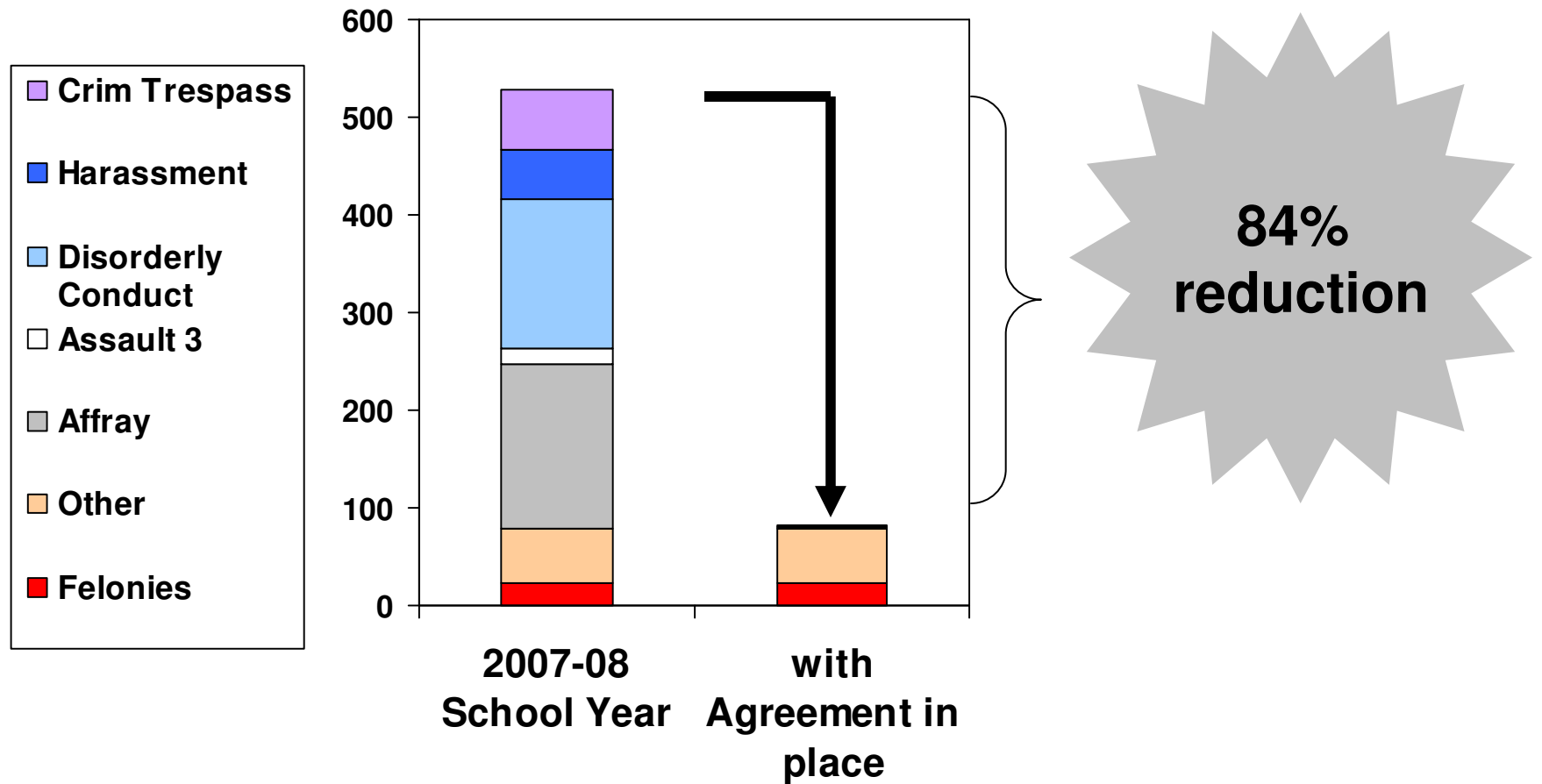
Get it in writing!

Results.....

More than 80% of school referrals to the Jefferson County Family Court come from the Birmingham City Schools.



The collaborative agreement will reduce court referrals from Birmingham schools by 84%.
